PORTFOLIO OBJECTIVES AND STRATEGY

The Wise Cautious Model Portfolio is designed for clients who are looking for a total return in line with the MSCI PIMFA Conservative index over a 5 to 10 year period, but with lower volatility than could be expected from full exposure to the stock market. We aim to achieve this by investing in a select and focussed list of funds (unit trusts, investment trusts and OEICs), with diversification across geography, asset class and investment style. These funds invest in real assets, such as company shares (listed both in the UK and overseas), property, fixed interest and cash. The Portfolio is selected with 20-60% invested in 'medium' risk assets, such as shares and property. 40-80% is held in assets defined as 'moderate', 'low' or 'minimal' risk, which are mainly comprised of fixed interest (UK government and higher quality company debt) and cash, and any remaining balance up to 5% can be invested in higher risk assets, such as shares in specific countries and industries. We therefore consider the portfolio to be suitable for those willing to adopt a cautious risk profile.

MONTHLY COMMENTARY

Global equity markets were slightly positive in May driven by US and Japanese equities with a fillip from the US dollar. The Technology sector led returns both in May and has done for the year so far. There are a number of factors at play here. Technology stocks reached excessive valuations in 2021 after supercharged spending by consumers and businesses during Covid. The slowdown in capital flows coupled with rising interest rates in 2022 led investors to review the prospects for Technology businesses ultimately concluding they were overvalued. Consequently, the sector sold off throughout most of 2022. However, just as markets can be excessively positive and overvalued (as they were in 2021), they can also be excessively negative and undervalue businesses (as in 2022). Therefore, part of the recent strong performance is a revaluation of the sector back to more sensible levels.

Another significant aspect driving performance is the excitement around artificial intelligence and its presumed ubiquitous application. There is no doubt in my mind that functions utilising artificial intelligence will increase substantially over time, but markets can often price the hype of a theme only to become disappointed when the reality of timescales and costs hit home. That is not to say the recent performance of Technology stocks can't continue. It's just that post revaluation, our expectations of return from this sector differs little from the broader market and so we see limited value in continuing to have a position concentrated in this area.

Listed real estate was weak whilst physical property indices showed a slight positive performance. The UK listed real estate index, with businesses such as SEGRO, Land Securities and British Land is now lower than it was during the depths of the Covid crisis. This is largely due to the rise in interest rates, concerns over banks' willingness to lend and the varied return-to-office policies applied since distancing measures were removed. There are undoubtedly challenges for commercial real estate generally (another is the cost of the retrospective mandatory fixing of the poor eco-efficiency of commercial buildings) but, like the Technology sector, we feel these things are being priced with overly aggressive negativity and therefore maintain a constructive exposure to the sector.

Long term UK interest rates moved higher over the month sending UK Government Bond prices lower. Inflation is declining at a slower pace than expected putting more uncertainty around the point when interest rate rises will peak and how long they might stay at these 'elevated' levels. Less rate sensitive areas such as corporate bonds performed better but were still lower on the month. Despite the correction in the yield curve, bond markets continue to price lower rates in the near future. This has created an (unusual) inverted yield curve where shorter dated yields are higher than longer dated ones making bonds with near term maturities look particularly attractive.


In the Cautious model portfolio, performance was lower by -2.1% in May. This was slightly ahead of the MSCI PIMFA Conservative index which was down -2.3%. In absolute terms, negative returns were driven by both bond exposure and equity strategies that also have a heightened sensitivity to moves in interest rates. The marginal outperformance came from the holding in the specialist Technology fund Janus Henderson Global Technology Leaders. Stocks such as Nvidia and Microsoft provided a significant contribution to the fund's return which have been driven by a general sector recovery and investor excitement around the future development of artificial intelligence.

The slight pullback in UK equities has improved valuations month on month making us more sanguine with a slight overweight in UK equities. Similarly, global equities continue to offer a reasonable return for the risk of holding cyclically sensitive assets. Our tilt towards Technology equities has reached a point where we don't envisage significantly divergent returns compared to the broader market. Listed real estate remains attractive and a potential driver of positive returns going forward as well as the attractive yield from shorter dated corporate bonds. Our challenge, as ever, is to allocate capital optimally amongst these areas to provide returns commensurate with risk appetite.


